

# **PUBLIC OFFER AGREEMENT**

## *for organisation of participation in a retreat program*

This document is an official public offer by Private Entrepreneur Andrii Steklov, registered in Ukraine, TIN 2199215651, hereinafter referred to as the “Organizer”, to provide program-related organizational, informational, and consulting services for participation in a retreat program.

### **1. Subject of the Agreement**

1.1. The Organizer agrees to coordinate and facilitate the Participant’s participation in a recreational, learning-based, and personal development retreat program on the agreed dates. The Participant agrees to attend the program and make payment as specified.

1.2. The Organizer’s program services may include:

- Yoga sessions, coaching sessions, and group workshops;
- Personal development and self-awareness practices;
- Communication and schedule support during the program;
- Program-related organizational, informational, and consulting support.

1.3. The Organizer may engage authorized independent specialists or practitioners to conduct certain program activities, including yoga sessions, coaching sessions, workshops, bodywork, or other personal development practices.

1.4. The program may include optional non-medical bodywork or relaxation sessions, where available, conducted by qualified independent practitioners. Such sessions are not medical, therapeutic, rehabilitation, or psychotherapeutic services.

1.5. Accommodation, kitesurfing lessons, meals, transport, excursions, flights, visas, and insurance are not included in the Organizer’s services and are arranged and paid for by the Participant independently or directly to third-party providers.

1.6. Flights, visas, medical insurance, including optional coverage for water sports, and all travel-related matters are the Participant’s sole responsibility.

### **2. Participation Conditions**

2.1. Participation is confirmed after:

- Completion of a registration form or written agreement;
- Confirmation of availability;
- Prepayment, the amount of which depends on the selected program option and services.

2.2. The remaining balance must be paid before the retreat program starts or at another time agreed individually by the parties.

### **3. Payments**

3.1. A deposit confirms the Participant’s place in the retreat program.

3.2. Accommodation, transport, excursions, kitesurfing lessons, meals, flights, visas, insurance, and other travel-related services are not included in the Organizer’s services and are paid by the Participant independently or directly to third-party providers.

3.3. The program fee covers:

- Coordination and planning of the retreat program;
- Communication with participants and partners regarding the program schedule;
- Yoga, coaching, workshops, and other program activities, where applicable;
- Program-related organizational, informational, and consulting support.

3.4. All payments are accepted in EUR or UAH, depending on the payment method and applicable regulations.

3.5. If payment is made through a payment service, the payment confirmation, electronic receipt, payment notification, or other payment document generated and sent by the payment service shall be considered sufficient confirmation of payment. The Organizer does not issue additional paper payment confirmations unless required by applicable law or separately agreed by the parties.

## **4. Liability**

4.1. The Participant voluntarily engages in all retreat program activities and is fully responsible for their own physical, mental, and emotional well-being.

4.2. The Organizer is not liable for:

- Services, actions, or omissions of third parties, including hotels, accommodation providers, kite schools, transport providers, guides, excursion providers, restaurants, or other independent service providers;
- Weather conditions, changes in wind or sea conditions, or other natural circumstances;
- Force majeure events;
- Lost, stolen, or damaged personal belongings;
- The Participant's failure to obtain visas, insurance, travel documents, or other documents required for travel.

4.3. Retreat program activities are not medical, psychotherapeutic, rehabilitation, or licensed educational services.

4.4. The Participant understands that yoga, coaching, workshops, bodywork, and personal development practices are provided for informational, educational, recreational, and self-development purposes only and do not replace medical, psychological, legal, financial, or other professional advice.

## **5. Cancellation and Refund Policy**

5.1. If the Participant cancels less than 45 days before the start date, the prepayment is non-refundable.

5.2. If the Organizer cancels the retreat program, the Participant will receive a full refund of any amount paid to the Organizer.

5.3. In the case of force majeure, including but not limited to war, natural disasters, pandemic, travel restrictions, border closures, strikes, or other circumstances beyond the control of the parties, both parties will resolve the situation by mutual agreement.

5.4. The Organizer is not responsible for refunds related to accommodation, transport, excursions, kitesurfing lessons, meals, flights, insurance, or other services paid by the Participant directly to third-party providers.

## **6. Acceptance of the Offer**

6.1. The Participant confirms acceptance of this public offer by:

- Making a deposit payment; or
- Making full payment; or
- Providing written confirmation via email or messenger.

6.2. By accepting this public offer, the Participant confirms that they have read, understood, and agreed to all terms of this Agreement.

6.3. This Agreement is valid from the date of publication on the Organizer's official website and may be updated without prior notice. The version of the Agreement published at the time of payment applies to the Participant.
